Rocketry is an inherently dangerous activity. Rules and procedures have been created to help make this activity as safe as possible. Everyone attending TIR events is participating at their own risk and is responsible for following the rules and regulations of TIR, National Association of Rocketry (NAR), and the Bureau of Land Management (BLM).

In consideration of being permitted to participate in rocketry activities with the TIR, the Participant understands, and does hereby freely, voluntarily, and without duress executes this Release and Waiver under the following terms and conditions:

- 1. Agrees and contracts on behalf of Participant and Participant's heirs, executors, administrators, successors and assigns that TIR, NAR, and the United States Department of the Interior – Bureau of Land Management and their insurers, employees, officers, directors, associates and volunteers shall not be liable for any damages arising from personal injuries, including death, or property damage sustained by Participant or any guests of Participant in, on, or about the rocketry events of TIR or as a result of the use of any facilities at such events, regardless of whether such injuries result in whole or in part from the negligence or fault of TIR. By the execution of this agreement the Participant accepts and assumes full responsibility for any and all injuries, damages (both economic and non-economic) and losses of any type and does hereby fully release and discharge TIR, NAR and the BLM from any such claims, demands, damages, rights of action or causes of action, present or future, whether the same be known or unknown, anticipated or unanticipated, arising from participation in any such event of TIR. Participant further agrees to indemnify and hold TIR, NAR and the BLM harmless against any and all claims, demands, damages, rights of action or causes of action of any person or entity that may arise from injuries or damages sustained by Participant or Participant's guests.
- 2. Assumes all of the risks, including property damage, injury, illness or even death and agrees to follow the safety code, rules and regulations of TIR, NAR and the BLM. Participant recognizes and understands that participation in rocketry involves inherently dangerous activities.
- 3. Understands that TIR cannot be held responsible for the failure of other participants to abide by the safety code and rules and regulations of TIR, NAR and the BLM.

- 4. Certifies that the Participant has the necessary certification, experience, and training if operating high-power rockets.
- 5. Expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Idaho and that if any portion thereof is held in valid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
